- » Represent ENA in renewable gas research activities.

- » Work collaboratively with other gas industry associations to develop a supportive policy environment for renewable gases.

- » Monitor renewable gas developments and maintain watching brief of key issues of interest to Energy Networks Australia members;
- » Act as a contact point for industry liaison on a range of related gas policy matters;
- » Contribute to organisational planning; and
- » Other duties as directed to support the activities of Energy Networks Australia.
